Respected Sir,

We respectfully submit the following points for your kind perusal and consideration:

1. Herewith submitting the issues related to our BSNL service for your kind perusal please.
 - a. The voice issue rises in the recent 4G migrated towers is to be resolved on priority please.
 - b. Regular voice only plan may be given for existing FTTH customers for migration, earlier in CDR2 Voice unlimited plan is available for migration but in CDR3 it is restricted to only new customers .
 - c. The standard instructions for the FTTH vendors may be given to provide NPC as lot of complaints recd that vendors demanding huge amount for providing connections and there is no uniformity among vendors.
 - d. The OTTs like SUNNXT, Netflix may be introduced in FTTH to add and also to retain the customers please.
 - e. A special platform may be arranged inclusive of the vendor support to address the technical issues then and there in CDR3 at par with Sanchar aadhar.
 - f. Lot of complaints received from International roaming customers in Singapore, USA, UK and Australia that our service not available there and it is learnt that the 3G services were shut down in that countries. Hence steps may be taken to restore the services please.

2. Mrs. KUMARIMALA - JAO Direct recruitment of 2018 batch and posted in Assam Circle w.e.f : 03.09.2018. From Dec-2021 she got temporary transfer and posted to Nagercoil BA on own cost basis.
