**1. DOT Status Shri.P.Gurumoorthy AO - reg**

The BSNL Absorbed status case of Shri.P.Gurumoorthy AO TNJ and P.Velayudham JAO TN Circle Chennai , who were recruited in 2000 and joined after the formation of BSNL. Subsequently they have issued presidential order and the DOT status maintained till 2007. Later they been converted to BSNL recruited status, and they approached CAT and then at High court got favourable orders.

We humbly request to take up the case in relevant establishments and on settlement the justice will be rendered please.

**2. AO(Regular), Promotion case of Shri. S.Subramanian**

Shri S.Subramanian deprived of assuming charges of AO(Regular) due to a third party complaint and the punishment imposed on him was downgraded to CENSURE by CGM TN Circle based on the dismissal of charge against the petitioner by Principal District Munsif Court Madurai.
