Subject: Request to keep the process of calling options for Inter-BA Transfers in abeyance till finalization of excess and deficit BAs – Reg.

Respected Madam,

Kindly refer to:

1. The letter issued by the Finance Wing calling for options from Accounts Cadre officers for Inter-BA transfers.
2. This Association's representation dated 27.05.2026 on "Transparent and Fair Implementation of Inter-BA Transfers, Publication of Sanctioned Strength & Long Stay List for Accounts Cadre."

In continuation of our above representation, we respectfully submit that the process of calling options from officers for Inter-BA transfers may kindly be kept in abeyance until the actual excess and deficit position of all Business Areas (BAs) is finalized based on the latest sanctioned strength and working strength.

As already represented, publication of BA-wise sanctioned strength, working strength and the combined long-stay list of Accounts Cadre officers is essential to ensure transparency, fairness and uniformity in the transfer process. Without first determining the actual shortage and excess position across all BAs, calling for options may lead to avoidable confusion, grievances and administrative imbalance.

Therefore, it is humbly requested that:

1. The latest BA-wise sanctioned strength and working strength of Accounts Cadre officers may kindly be published.
2. A transparent exercise may be undertaken to identify excess and deficit BAs based on the updated data.
3. The combined long-stay list of Accounts Cadre officers may also be published.
4. The present exercise of calling options for Inter-BA transfers may kindly be kept in abeyance till the above exercise is completed and the excess/deficit position is finalized.
