Subject: Request for deferment of proposed long-stay transfer orders of AO/JAOs until closure of the membership modification window

Respected Sir,

It is understood that the Circle Administration is considering the issuance of long-stay transfer orders in the cadre of Accounts Officers (AOs) and Junior Accounts Officers (JAOs).

In this regard, we wish to bring to your kind notice that the membership modification window for service associations is scheduled to remain open from 16.06.2026 to 15.07.2026. During this period, executives are provided an opportunity to continue, modify, switch, or withdraw their association membership.

The issuance of transfer orders during the above period may cause concern and uncertainty among the affected executives and could inadvertently influence their decisions regarding association membership. While there may not be any specific guideline prohibiting such administrative actions during the membership modification window, the spirit of ensuring a fair and uninfluenced opportunity for executives to exercise their choice deserves due consideration.

It is also respectfully submitted that, during the membership modification window, any major administrative exercise such as long-stay transfers may inadvertently give rise to perceptions or speculation among employees. There is a possibility that interested quarters may attempt to canvass that certain transfers, postings, or retentions have been secured through the efforts or influence of a particular association, even when such administrative decisions are taken strictly in accordance with the prescribed rules and in a transparent manner by the competent authority. Such perceptions, though entirely unfounded, may influence some executives while exercising their option regarding association membership and may lead them to take decisions based on such misconceptions.

In view of the above, AIBSNLEA Tamil Nadu Circle humbly requests the Circle Administration to defer the proposed long-stay transfer orders of AO/JAOs until the closure of the membership modification window on 15.07.2026. Such a course of action would help avoid any unintended impact on the exercise of membership options by executives, prevent any scope for
